## FINANCIAL OBLIGATION

If accepted, please note that there is a registration fee, per student/faculty member of \$795.00 to participate in the 2022 NSF Case Cup (*Note: This fee also covers the student/faculty member's registration to the 2022 National Sports Forum that follows the competition, February 26th - February 28th, 2023*). Each team is required to have four students and one faculty advisor. The minimum total fee per school is \$3,975.00

$$\$695.00/\text{person} \times 5 (4 \text{ Students} + 1 \text{ Faculty Advisor}) = \$3,975.00$$

All participating schools must submit a non-refundable deposit of \$1,000.00 by October 30, 2022 order to secure their placement in the Case Cup Competition. If the deposit is not received by said date, their spot in the competition will be vacated and awarded to another school.

The remaining balance of \$2,975.00 will be due in full no later than November 15, 2022. Failure to remit payment on/before this date will terminate the school's placement in the competition – with the \$1,000.00 deposit being forfeited by the selected school.

Other students and faculty members may register at the same \$795.00 rate, but only four students may participate in the competition.
